It is to be informed that several H.T. Consumers filed Writ Petitions before the Hon’ble High Court of Madras/Madurai Bench challenging the impugned Circular in reference 2nd cited . The above cases in W.P.5916/2014 and batch matters were heard by the Hon’ble High Court of Madras and orders were passed on 14-09-2018 quashing the circular 2nd cited. (Copy of High Court Order enclosed)

Aggrieved by the orders of the Hon’ble High Court of Madras dt: 14-9-2018 in W.P. 5916/2014 & Batch matters, TANGEDCO has filed Writ Appeal No. 2539/2018 in W.P. 5916/2018 in the case of Rasi Tex HT SCNo.192 of Salem EDC and Writ Appeal No. 2540/2018 in W.P. 22369/2015 in the case of M/s India Cements Ltd., pertaining to Tirunelveli, Perambalur, Mettur and Chennai (North) EDCs.

The above Writ Appeals were admitted during the hearing on 19-11-2018 before the Hon’ble High Court of Madras and the Hon’ble Division Bench of the Madras High Court ordered to continue to collect the 50% of the deemed demand charges as was done earlier. The case was posted to 17-12-2018.

Therefore, all the Superintending Engineers/EDCs are instructed to send the signed Vakalat for each case separately and copy of the Affidavit filed by the HT Consumers along with the connected files in respect of cases pertaining to their Circle in person by tomorrow i.e. 20-11-2018 positively .

As the stake involved is huge, the same may be treated as **MOST URGENT.**
