CIRCULAR

Dear Members,

Sub: Submission of documents for CGP verification - Reg -

Ref: The Common Order of Hon'ble TNERC dated 07.12.2021 in M.P. No. 24

of 2020.

In continuation to the subject referred above, we would like to inform our members that TNERC vide its above referred Order, directed all the CGP holders (100% captive and Group captive consumers) to submit the data as specified in the 'Procedure for verification of CGP status' to TANGEDCO/verifying Authority every year.

The documents for CGP verification for the year 2022-23 have to be filed on or before 31.05.2023 with the concerned Superintending Engineer at where WEGs/Solar Power Plants is located. Those who have multiple WEGs, at multiple locations, can file the documents in respect of all their WEGs/Solar Power Plants owned by them, with the Superintending Engineer of the Consumption End.

While filing the documents, proper acknowledgement should be obtained from the SEs concerned, with their seal and stamp or the documents can be sent by e-mails and RPAD and Postal Acknowledgements can be tracked and kept ready when any dispute comes on the issue of non-filing of documents.

These instructions provided as above are only pertaining to 100% owned WEGs / SPGs and not for Group Captive Power.

In respect of member's sourced power from Group Captive CGP Sources, the concerned Generator would seek Format-II / Format-IV as the case may be, from the Captive Users and that alone has to be got it signed by the Chartered Accountant and returned back to the concerned Generator. In Group Captive Power, the responsibility to file document for CGP verification is resting with the Generator only and not with the Captive User.

Please note that to avail the open access, whether for captive or group captive, the relevant documents (proof of ownership/shareholding pattern) as prescribed by the Hon'ble Commission, is to be submitted to TANGEDCO for obtaining approval for wheeling (i.e., within 30 days when the number of captive users are less than 50 and within 45 days when the number of captive users are above 50, preceding the date on which the wheeling is sought).

Also It is relevant to note that to claim the encashment for the unutilized surplus units, at the end of each year, it is mandatory to comply with the prescribed captive status of the power plant.

Hence, concerned members are requested to proceed to verify their CGP status each year to ensure appropriate compliance, so as to avoid being subject to the levy of cross subsidy surcharges and ease the claim of encashment of unutilized surplus units.
