Subject: Hon'ble Supreme Court Order dated 09.03.2026 – Representation to TNPDCCL on Deemed Demand Charges

As informed through our WhatsApp message dated **12.03.2026**, please find attached the **Order of the Hon'ble Supreme Court dated 09.03.2026**, along with a **Note explaining the computation of the limitation period**.

We are also enclosing a **Judgment of the Hon'ble High Court dated 18.06.2019**, wherein the Hon'ble High Court has ordered that **BPSC amount shall be collected only at 12% and not at 18%, when the delay occurred due to Court proceedings**.

Further, we are enclosing a **Model Letter**. Accordingly, **all members covered by the arrears under the Deemed Demand Charges matter may act upon the same as advised below**.

Instructions to Members

1. The **Model Letter should be printed on the company's letterhead**. It should **not be sent directly as the body of the email**, but **only as an attachment**.
2. The **Model Letter should be suitably filled in**, wherever blanks are provided, based on the records available with the respective members.
3. The **E-mail IDs of all the SEs / DFCs are enclosed in a separate sheet**. Before sending the letter by email, the **concerned SE and DFC email IDs should be inserted in the Model Letter**.
4. The **Letter should be duly signed and scanned**, and **only thereafter sent as an attachment**.
5. The **body of the email may be written as follows**:
