Sub: Renewal of Factory License under DISH for the year 2025-Regarding.

## \*\*\*\*

Members may be aware that renewal of factory license under DISH for the year 2025, is due by 31.10.2024. Any application not filed before the due date would attract 10% surcharge, if it is filed before 30th November 2024 and 20% surcharge, if it is filed by 31st December 2024. The license application if not filed beyond 31.12.2024, would make the license expired. Therefore, after the expiry of factory license as on 1st of January 2025, the surcharge payable would be 30%, in addition to penalty if any by way of prosecution by the DISH at Criminal Courts.

To avoid all the repercussions, members are advised to file their renewal applications by online with the DISH Portal well before 15th October 2024 without waiting for the last date to happen and also to file the same when the Portal is free from possible congestion. Every time heavy congestion is experienced.

As like last year, the renewal fee has to be paid by NEFT and no Demand Draft will be accepted. After receipt of renewal fee by NEFT, the Factory License will be renewed and members can download the same for the physical copy. Application in Form No. 2 has to be uploaded, only in the portal of the DISH, as per the User ID and Password, already provided. As this is the 5th occasion to file the license renewal fee by NEFT, members are requested to initiate their actions well in advance or otherwise they may not get the portal support at the fag end. The fee Schedule is communicated along with this Circular and it can be also seen from the Annual Report of TASMA for 2023-24 also. Accordingly, members can attempt to renew the license by paying the fee through online by NEFT without any omission, well before the due date.

For transfer and amendments of license, Authorities in DISH can be consulted as how to regulate the amendments and transfers.

A soft copy of Blank Form No. 2, in word format is also attached for their subsequent filing with DISH and the same can be also used for transfer and amendments of license if required. The Government of Tamilnadu has proposed to revise the License Fee upwards and however, no final order was passed yet. Hence, payment of license fee can be made as per the chart attached at the existing rates.
