CIRCULAR

Dear Members,

Sub: Revised SOPs notified by the MoP in the matter of uploading of pending payments receivable from DISCOM / TANGEDCO in the PRAAPTI Portal- Regarding

Ref: The communication of the MoP in F.No.10/03/2022-UR&SI-II- (E-263775) dated 11.04.2023.

Please find enclosed the soft copy of the communication of the Ministry of Power (MoP) for the reference of Members those who are selling their Solar/Wind energy to the TANGEDCO as **Generation Company**.

Accordingly, the members are requested to follow, while they process the uploading of the invoices for payments receivable from the DISCOM / TANGEDCO.

Importantly the payment towards encashment of unutilized wind energy, during the end of the financial year and payment towards encashment of Solar Energy, unutilized during the end of every month, need not be entered in the PRAAPTI Portal, as they are not regular cases of pending payments. In such cases, if members see that a considerable amount has accumulated and a considerable time was exhausted from the date of raising the invoice, they can straightaway file a Writ Petition at the Hon'ble High Court and can seek a direction to make the pending amount adjusted against their future CC bills / other payments payable to the TANGEDCO. These are all the cases of captive users of Solar/Wind Energy and therefore, such captive users cannot be considered as supplier or Generation Company. This position has to be ensured diligently.

In respect of all other regular 'Sale to Board' cases, such members can raise the invoice on a month-on-month basis and accordingly, **within five days of raising the invoice, including the holidays if any intervened**, they have to upload the invoice in the PRAAPTI Portal without any delay or default. The link for the PRAAPTI Portal for uploading the copies of the invoices is as below.

Members have to register in the PRAAPTI Portal as **Generation Company**.

However, members who are generators and who were supplying the power to the TANGEDCO, can read out of the contents of the communication of MoP in full for completely understanding the matter for suitable follow up.
