Adverting to the above, approval is hereby accorded for accepting quality materials from the HT applicants seeking erection of dedicated feeders for the work to be carried out by TANGEDCO, with the following conditions:

(i) The quality of materials shall be checked scrupulously by the SEs/EDC concerned and it shall be ensured that the equipments/materials for the work are procured as per Board's Standardized specification and convention conforming to the Standards and as per relevant ISS. No Material/equipment bought from the firms which are black listed by TANGEDCO shall be accepted.

(ii) The Gross amount of the estimate (as per current cost data rates) with 5% contingency, 3% storage, 30 % Labour & Transport and 22% Estt. & Supervision, deducting the cost of materials supplied by the applicant (as per current cost data rates) may be collected in advance in full before commencing work.

(iii) Work shall be commenced by TANGEDCO after all the materials are supplied by the applicant.

(iv) An undertaking in Rs.80/- non-judicial stamp paper shall be furnished by the HT applicant seeking dedicated feeder to the effect that:

(a) The equipments/materials for the work are procured as per Board's Standardized specification and convention conforming to the standards and as per

relevant ISS. No Material/equipment shall be bought from the firms which are black listed by TANGEDCO.

(b) All the materials will be supplied by the applicant before the commencement of work. In case of any delay in commencement of work due to non supply of the required equipment/cable etc, TANGEDCO cannot be held responsible.

(c) The Gross amount of the estimate after deducting the cost of materials supplied by the applicant (as per current cost data rates) will be paid in advance in full before commencing work.

(d) If any equipment failure arises in future, the replacement of the same shall be met by the HT applicant. In case of any delay in restoration of supply due to non supply of the required equipment/cable etc, TANGEDCO cannot be held responsible.
