PROCEEDINGS:-

In the proceedings read above, orders were issued among others to delegate the powers of the Chairman-cum-Managing Director to Director (Distribution) and Executive Engineer for sanction of the powers in respect of reduction of loads. The details are as follows :-

Item No.1.3 : To sanction reduction of Loads :

Sl. No.	Authority	Powers
1.	Director (Distribution)	Full Powers (for EHT/HT level)
2.	Executive Engineer	Full Powers (for LT level)

Even after delegating the powers as mentioned above, various execution problems were observed at field level and caused more delay in getting the sanction.

2. In order to avoid delay in sanctioning the load reduction proposals, it has been proposed to issue an amendment to the orders issued in the proceedings first read above in respect of Item No.1.3 ("to sanction reduction of loads") mentioned in para-2 of the said order under the caption of Capital Works.
