**The following is the Status of hearings held at TNERC on 29.06.2021 on following important matters.**

1	M.P. No. 24 of 2021	The TANGEDCO has prayed for an order on priority of adjustment of OA power sourced by HT consumers from different sources / categories.	Even though, such a matter of changing the priority of adjustment was one among the actions proposed in Circular Memo No.CE/GO/SE /Comml.Opn/EE/OA/F.Exchange/D102/20 dated 17.07. 2020 of TANTRANSCO, the said Circular was already challenged by TASMA in WP No. 10069 of 2020 and accordingly, the operation of the Circular was stayed by the Hon'ble High Court.  However, even after mentioning the sub-judice nature of the matter before the Hon'ble High Court, the Hon'ble Commission has admitted the petition of the TANGEDCO in M.P. No. 24 of 2021 and accordingly, ordered to webhost the petition for comments of the stakeholders and posted the matter for next hearing on 27.07.2021. 2	M.P. No. 20 of 2021	This is a matter relating to Rollover of unutilized units during the Pandemic period.	This Petition has filed by IWPA. The petition was admitted and TANGEDCO has to file a counter on it. Matter adjourned to 13.07.2021.	TANGEDCO file the counter
