### **CIRCULAR**

Dear Members,

Sub: TNERC Order in Interest on Security Deposit and Meter Caution Deposit kept with TANGEDCO for the financial year 2024-25 for HT and LT consumers.

Ref: The TNERC **Order No. 2 of 2025 dated 10-02-2025**

In continuation to the above, we wish to inform our members that Hon'ble TNERC has notified the interest rate for the Security Deposits and Meter Caution Deposits @ 6.75% for the year 2024-25. Please note that the rate from the year 2023-24 of interest was maintained for the year 2023-24 @ 6.75%

Based on this order, the TANGEDCO will work out the interest applicable as on 31.03.2025 and will credit the interest on the Security Deposit / Meter Caution Deposit, held by the consumers with the TANGEDCO, before 30.06.2025, to each of the consumers' accounts and will intimate the same to each consumer.

Requirements for Additional Security Deposit / Additional Current Consumption Deposit (ACCD), if any, required to be maintained for the year 2025-26, for payment, will be demanded by a separate demand notice and the same has to be paid to the TANGEDCO within 30 days of the date of demand.

In case of any demand for an Additional Security Deposit (ASD) / Additional Current Consumption Deposit (ACCD), Members have the option to pay the Additional Security Deposit (ASD) or Additional Current Consumption Deposit (ACCD) in three installments by contacting the relevant SE.

If any member wants more than 3 installments and however, not beyond 6 installments can approach our Legal Team to file a Writ Petition and get a Court Order to pay the deposit up to a maximum of 6 installments. This should be acted upon immediately once demand notices are received from the TANGEDCO for ASD/ACCD.

We are enclosing the soft copy of the TNERC order for members' reference.
