Sub: Encashment of unutilized wind energy and other payments receivable from TANGEDCO-Court Ordered to adjust such amounts against CC bills and other payments payable to TANGEDCO-Final Order of the Hon'ble High Court dated 28.10.2021 in a Batch of matters-Communicated.

Please find enclosed herewith the soft copy of Order passed by Hon'ble High Court dated 28.10.2021 in Batch Petitions filed by various WEG's seeking adjustment of outstanding dues payable by TANGEDCO to the respective petitioners towards the current consumption charges.

The Hon'ble High Court has allowed all the petitions. But as a matter of choice, the Hon'ble High Court was willing to provide an option to the TANGEDCO to bring out a 'Policy Paper' and however, in spite of several opportunities provided to the TANGEDCO, the TANGEDCO has not come forward to file the 'Policy Paper' before the Hon'ble Court till 28.10.2021. Accordingly, all the Batch of Writ Petitions were closed on 28.10.2021 with the following directions.

"11. In view of the above, all these **Writ Petitions are Disposed** of with the following directions:-

- (a) *In all those cases where the TANGEDCO has acted upon the interim orders passed by this Court and the entire outstanding amounts due and payable has been adjusted, those writ petitions will be rendered infructuous since the grievance of those petitioners stands redressed;*
- (b) *In those cases where the TANGEDCO is in the process of adjusting the outstanding amount due, such adjustment shall be continued till the entire outstanding amount is adjusted towards the current consumption charges / open access charges payable by the respective petitioners and*
- (c) *The TANGEDCO shall not take any coercive steps to disconnect the electricity connection to the petitioners until the outstanding amounts due and payable is completely adjusted towards the current consumption charges/ open access charges payable by the petitioners.*

12. Post these cases under the caption "for filing final report" on 23.12.2021 with regard to the subsequent developments that takes place in the meeting to be held on 20.12.2021 and also with regard to the submission of the policy
